**Request for Urgent Preemptive Statement on the Situation in Rafah**

**Dear Mr. Khan,**

We, representing various Palestinian human rights organizations and Civil Society Organizations (CSOs), alongside the undersigned National Human Rights Institution, are reaching out to you with an urgent plea for your attention and intervention concerning the recent Israeli threats to invade Rafah, the southernmost area of the Gaza Strip. With a population of approximately 280,000 people before the war, Rafah has become a last refuge for approximately 1.3 million internally displaced persons (IDPs) who are currently facing severe shortages of food, water, shelter, and medical supplies.

The threats of an Israeli incursion into Rafah have raised grave concerns about the potential for a humanitarian catastrophe in an area already serving as a critical sanctuary. The United Nations Secretary-General has warned that expanding the scope of hostilities to Rafah would significantly exacerbate an already dire humanitarian nightmare, with countless regional repercussions.

Furthermore, the forced displacement of the population toward Rafah and the escalation of bombings raise the potential for forcing over 1.3 million people into involuntary migration toward Egypt. Such actions could result in massacres or forced displacements, further destabilizing the region.

In light of these pressing circumstances, we kindly request that your esteemed office promptly investigates these actions and threats and issues a public statement on the matter. The people of Gaza urgently need international intervention and support. A clear stance from the International Criminal Court would not only demonstrate global solidarity but also send a potent message that such actions will face scrutiny and potential accountability.

We believe in the International Criminal Court's crucial role in ensuring justice and accountability in this critical situation. Your prompt attention to and action on this matter would be immensely appreciated and could help avert further escalation of this humanitarian crisis.
